Working across the South of England we provide a comprehensive range of services that enable individuals to access and make the best use of budgets provided through community care Direct Payments, Personal Budgets and Individual Budgets. We also offer services to individuals who do not qualify for social services but who would like support to manage their care/support needs.

WHAT ARE.....

Direct Payments

A payment direct to you so that you can arrange your own care/support services, giving you choice, control and therefore more independence. You must be willing and able to manage the Direct Payment, with or without support and you must be willing to accept responsibility for arranging your own care/support services.

Personal Budgets

Money the Council allocates to help an adult with care needs to get the support they want. If you wish, you can have a Personal Budget paid to you by Direct Payment and arrange your support yourself this is called Self-Directed Support.

Individual Budgets

Money from several sources such as Independent Living Fund and Access to Work as well as community care funding. This is amalgamated into one budget and can also be Self-Directed via a Direct Payment.

HOW MUCH DOES IT COST?

Annual costs will vary according to how much support you choose to have. However, the hourly charge is £20 and the minimum cost is likely to be around £250 per year.

If you are in receipt of a community care budget the cost of our service may be included in your budget.
